INTRODUCTION

This compilation is a compendium (or inventory) of all historical records found to date that mention one or more individuals with the surname of Kidd in Mecklenburg County, Virginia from the time of its founding in 1764 through 1850.

We began the ambitious task of producing these documents for over twenty Virginia counties with several objectives:

- 1. To find virtually every existing record mentioning the surname of Kidd in these Virginia counties prior to 1850;
- 2. To analyze these records and ascertain (if possible) whether the individuals are descendants of the Thomas Kidd who arrived in the Virginia colony by 1648, and if so, their line of descent; and
- 3. To distinguish between proven, documented relationships and those which are widely shared and held to be accurate, but for which proof is minimal or non-existent.

MECKLENBURG COUNTY and its records

Mecklenburg County was formed on 26 May 1764 from Lunenburg County. The county seat is Boydton.



Mecklenburg County borders the North Carolina counties of Warren, Vance, and Granville; and early residents of Mecklenburg County, including members of our Kidd family, can be found in records from counties on both sides of the state line.

Land, Probate and Marriage records are available for Mecklenburg County from 1765 (though the birth, marriage and death records are incomplete), and birth and death records from 1853. There have been no major record losses for this county, but the federal censuses for 1790, 1800, 1810 and 1890 are not available.



This map is circa 1870, and contains the local landmarks and roads of that era, as well as the names of many of the residents. It displays in 16 sections, each of which can be enlarged by clicking on it. For example, click on Section 16, in the lower right corner, and you'll see in the upper right of that section "Mrs. Kidd" just west of Blacks Road, south of Marengo. This most likely refers to Mrs. Elizabeth M. "Betsy" Rainey Kidd, the widow of John B. Kidd.

This document is a compilation of all citations of individuals with the surname of Kidd in Mecklenburg County, Virginia from its formation in 1764 to 1850. Within it, individuals appear in alphabetical order, by their given name. Entries for each individual are arranged in chronological order, and where more than one person has the same given name, we've attempted to distinguish between them by other factors, such as varying amounts of land, slaves or other property, etc. When that is not possible, we've left the data elements under one name, while recognizing that those facts may represent more than one person.

The Kidds of Mecklenburg County in this era (1764-1850) consist almost entirely of two distinct groups, each headed by a patriarch named James Kidd.

The earlier James Kidd, whom we've labeled James(1) Kidd because he was the first Kidd to arrive in Mecklenburg County, was in the area prior to the creation of Mecklenburg County. He and his children left many records here, and most of them migrated to Oglethorpe County, Georgia before 1800. The origins of James(1) Kidd are unproven at this time.²

The other James Kidd (we call him James(2) Kidd in this compilation) did not arrive in Mecklenburg County until 1816, along with some of his children. We postulate that this James Kidd was the son of George Kidd, Sr. of Amelia County, Virginia, based upon his paper trail and the close Y-DNA match between his descendants and other proven descendants of George Kidd Sr. See James(2) Kidd's section of this compilation for more information.

BARTLETT M. KIDD, the son of John B. Kidd and Elizabeth M. Rainey born 16 Aug 18263 in Mecklenburg County, VA died 19 March 1862 in the Civil War

1850 – Bartlett Kidd appears for the first time on the Mecklenburg County, VA PPTL this year, taxed only for his own tithe. (This is the last year of the Mecklenburg PPTLs that we've checked.)

He's on the federal census in 1850 in his parents' household. See the section for John B. Kidd in this paper.

- 1853 Bartlett M. Kidd married Virender Jones 11 August 1853 in Warren County, NC.4
- 1860 He is on the federal census in Mecklenburg County, VA, p. 25, HH 207:

Kidd, B.M. 34MW farmer \$100 VA cannot read or write

- ", Verenda 27FW VA cannot read or write
- , Charles 5MW VA
- ", George 4MW VA
 ", John 2MW VA
- ", Saml. 5/12MW VA
- 1862 Bartlett M. Kidd served as a private in the 22nd Battalion/2nd Virginia Artillery Co. D under Captain James Alexander, and died 19 March 1862 at Glebe Hospital in the Richmond/Henrico County, VA area.5

EDWARD R. KIDD, the son of John B. Kidd and Elizabeth M. Rainey Born 5 Jul 18226 in Mecklenburg County, VA

Married (1) Tabitha Glover, daughter of Granderson Glover by his first wife,⁷ and (2) Mary H. Burton, daughter of Robert and Jane Burton. Died August 1870 in Mecklenburg County, VA

- 1847 He appears for the first time on the Mecklenburg County, PPTLs in 1847, taxed only for his own tithe. He reappears annually through 1850, the last year we've checked.
- 1850 I've not found him on the federal census in 1850. He's not in his father's household.
- 1860 He is on the federal census in Mecklenburg County, living alone:⁸ **Edward R. Kidd** 35MW farm laborer (b'place blank on entire page)
- 1861 **Edward Kidd** enlisted in Co. B, 56th Virginia Infantry Regiment on 22 June 1861 as a private.⁹
- 1864 On 31 March 1864, Edward R. Kidd married Tabitha Glover, the daughter of Granderson Glover by his first wife.
 Tabitha died young, evidently during or soon after the birth of their son Richard Kidd.
- 1866 **Edward R. Kidd** married his second wife Mary Burton on 21 November 1866 in Mecklenburg County, VA.¹¹ Her mother Rebecca Burton provided a statement of consent to this marriage to the Mecklenburg County Court Clerk.¹²
- 1870 On the federal census in Mecklenburg County, VA, South Hill twp., Boynton P.O., p. 10, HH 80/68:

Kidd, Edward R. 46MW miller VA can read and write

- ", Mary 20FW keeps house VA cannot read or write
- ", Richard 6MW VA

He died in August of 1870 in Mecklenburg County, VA. His death record lists his occupation as "miller," and named his parents as John and Elizabeth Kidd. ¹³ Family lore includes a story passed down in several branches of this family, saying that Edward and his second wife Mary died the same night, with young son Richard waking up in the morning and finding them both dead. ¹⁴ This story is supported by the fact that his entry in the Mecklenburg County Death Register is followed by hers. Both died of "chills" (the day of their deaths is not listed), and the informant for both deaths was Zach Jones, a

Julie Cabitto writes: "Edward Kidd (son of John B. Kidd) married Tabitha Glover. Tabitha was d/o Granderson Glover and Clarkey Anderson. After Clarkey died in TN, Granderson brought his two daughters to Mecklenburg and married Arimenta Kidd (d/o John B. Kidd). After Granderson died is when Tabitha and Edward married. So when Tabitha Glover married Edward Kidd, Arimenta Kidd became her step mother and sister-in-law at the same time. Tabitha didn't live very long and most likely died in child birth with Richard Kidd in 1864. Edward married Mary Burton in 1866. Both Edward and Mary Kidd died in Aug 1870 from Consumption and I lost track of where Richard Kidd went. Richard would've only been 6 years old when his father died."

neighbor. Mary's parents are listed in this record as Robert and Jane Burton of Mecklenburg County.

ELIZABETH (BEASLEY) KIDD, the daughter of John Pitts Beasley¹⁵ of Amelia County,

VA¹⁶ and Warren County, NC,¹⁷ and the wife of James(2) Kidd, aka James L. Kidd Born before 1774,¹⁸ probably in Amelia County, VA

Married James (2) Kidd before 1794,19 most likely in Warren County, NC

Died on 17 June 1821,20 most likely in Mecklenburg County, VA

ELIZABETH ANN (KIDD) TEMPLE, the daughter of James (2) Kidd and Elizabeth

Beasley

Born about 1804,²² most likely in Warren County, NC²³ Married Riddick Temple in 1825 in Mecklenburg County, VA

Died in November 1855 in Brunswick County, VA

1825 – A Mecklenburg County marriage bond was issued 20 July 1825 for the marriage of Riddick Temple and **Elizabeth Ann Kidd**. The surety for this marriage bond was John B. Kidd, her brother. Consent was given by James L. Kidd, her father. ²⁴

¹⁵ John Pitts Beasley died testate in Warren County, NC before May Court 1792, when his will was presented in Court and admitted to record. His will did not list his children by name. We know that Elizabeth Beasley was one of them because she and her husband, James Kidd, received one share of JP Beasley's estate when it was distributed to his heirs in 1805. See her husband's section of this document for details.

John Pitts Beasley is found on the Amelia County tax lists in 1765 and again in 1766, without land or slaves; he's also listed under Thomas Tabb, a large landowner (over 6000 acres) and slaveholder (87 slaves in 1765), one of twelve white men (evidently overseers or managers who worked for Tabb) for whom Thomas Tabb paid their tithe/poll tax. JP Beasley drops from the Amelia County Virginia tax lists by 1769 (no lists are available for 1767 or 1768) and does not reappear on them.

John Pitts Beasley was in Bute County, NC by 22 November 1777, when he purchased 209 acres of land on the waters of Haughtree (Hawtree) Creek from Francis Rees and Ann Rees his wife for £100 Virginia money. Bute County ceased to exist in 1779, when it was split to form Warren County and Franklin County. 1855 – **Eliza A. Temple** died of cancer in November (day not listed) 1855 in Brunswick County, VA. Her death record lists her age at death as 50 years, her birthplace as Mecklenburg County, VA, and her parents as Jas. and Eliza Kidd.²⁵

Her husband Roderick Temple was the informant for this record. He outlived her and married again, and died in 1869.

- ELIZABETH M. "BETSY" (RAINEY) KIDD, the daughter of Williamson Rainey, Sr.²⁶ and Edith Morgain/Morgan²⁷ of Mecklenburg County, VA, and the wife of John B. Kidd Born 15 May 1794,²⁸ most likely in Mecklenburg County, VA Married John B. Kidd on 19 February 1818 in Mecklenburg County, VA Died sometime after the 1880 federal census
- 1818 A marriage bond for John Kidd and Betsy M. Rainey was issued 16 Feb 1818 in Mecklenburg County, VA. The surety was William Rainey, and Williamson Rainey Sr., father of Betsy, gave his consent.²⁹
- 1820 In a deed dated 25 August 1827, **John B. Kidd and Betsy M.**, his wife, of Mecklenburg County sold to Roderick Temple of Brunswick County, "For and in consideration of the love and affection for Roderick Temple our brother-in-law and for \$1," a tract of land on Charles Jones line, a sweet gum on Great Creek, along Jones' line to Hunters Mill pond, etc.,

and containing 198½ acres. Signed and sealed by John B. Kidd; signed with mark by **Betsy M. Kidd**.

Witnesses to this deed were James Kidd and Sally Griffith.

On 30 March 1833 the justices of the peace certified that Kidd personally acknowledged the deed and that Betsy relinquished her dower rights. Deed recorded 15 April 1833.³⁰

1830 – The household of John B. Kidd is found on the 1830 federal census in Mecklenburg County, VA, part 2, page 58:

John D. (sic) Kidd - one WM<5, 3 5-9, & 1 30-39; 1F 5-9, 1 10-14 & 1 30-39 and 1 60-69. Ten slaves. Betsy is believed to be the white woman aged 30-39. The identity of the older white woman is unclear.³¹

1833 – On 30 August 1833, **John B. Kidd** and his wife **Betsy M**. for the sum of \$110 sold to Elizabeth Wall a tract of land in Mecklenburg County adjoining Barber, Z. Jones, and Robin Thomas, containing 50 acres. Signed and sealed by John B. Kidd; signed by mark by **Elizabeth M. Kidd**.

On 20 August 1833, justices of the peace certify as to acknowledgment of this deed by John B. Kidd, and **Elizabeth Kidd's** relinquishment of dower.

Deed recorded 10 February 1834.32

- 1846 The Mecklenburg County will of Williamson Rainey, which he signed on 8 Jan 1846, bequeathed two slaves and other property to his daughter "Elizabeth M. Kydd" [wife of John B. Kidd].³³

1862 – John B. Kidd died September 1862 in Mecklenburg County, VA.34 His will, dated 12 Jun 1862, leaves bequests to his wife **Betty M. Kidd** and their children.³⁵ His probate documents, listing all his heirs, are available online at this URL:

Kidd, Elizabeth mother-in-law WF 84 widow at home VA VA VA Lambert, Earnest servant BM 13S farm laborer VA VA VA

She died sometime after the 1880 federal census; the date and place of her death are not known. She does not appear on the Mecklenburg County Death Registers, 1853-1896. The most likely place that her death might be recorded is in the Chancery Court records mentioned above. These records have not yet been digitized.

FRANCES (ROBERTSON) KIDD, third wife of James(1) Kidd Married James(1) Kidd in 1795. They had no known children. Moved with her husband to Oglethorpe County, GA ca 1797 Died before October 1813³⁸, likely in Oglethorpe County, GA

- 1795 A marriage bond dated 8 Aug 1795 was issued in Mecklenburg County, VA for James Kidd and **Frances Robertson**, surety Mark Robertson.^{39 40} This bond includes the signature of James Kidd.
 - Note: A marriage bond was also issued in <u>Warren County, NC</u> on 16 September 1795, for the marriage of James Kidd to **Frankey Robertson**. Simon Williams was the bondsman, and M. Duke Johnson was the witness. This may indicate that Frances Robertson was from Warren County, NC.]
- 1795 In a Mecklenburg County deed dated 11 Nov 1795, James and Frances Kidd of Mecklenburg County sold to William Hendrick for £180 a tract of land containing 222 acres, bounded by Nutbush Creek and lands of John Tanner and William Kidd. This deed was recorded 8 September 1800.⁴¹
- 1810 In an Oglethorpe County, GA deed dated 10 June 1810, James Kidd conveyed to **Frances Kidd, "his loving wife,**" a life estate on 119 acres on headwaters of Grove Creek in Oglethorpe County, GA, a Negro slave Jenny, and household items. Upon the death of **Frances Kidd**, all this property to go to "my son" Anderson R. Kidd. Also additional property to go to Anderson R. Kidd, including four-year-old male slave Shadrack. If Anderson R. Kidd should die without heirs, then all the above property is to go to "my son" John Kidd and his heirs.⁴²
- 1813 On 4 October 1813, Anderson R. Kidd sold this 119-acre tract to Pascal Murphy for \$300,⁴³ evidence that **Frances Robertson Kidd** had died before this date.

JAMES(1) KIDD – Parents unknown

Likely born by 1737 in Virginia⁴⁴

In Lunenburg County, Virginia by 1758, in the part of Lunenburg that became Mecklenburg County in 1764-5

Married three times, to 1) unnamed daughter of Mary Addaman Stevens, 2) to Winifred/Winny Hudson, daughter of Robert Hudson, and 3) to Frances Robertson (as outlined below).

Remained in Mecklenburg County, Virginia until circa 1797, when he followed his sons to Oglethorpe County, Georgia Died in Georgia abt. 1816.

This James Kidd has been claimed, *without any proof whatsoever*, to have been the son of James3 (William2, Thomas1) Kidd and his wife Elizabeth. We include this claim here solely for the purpose of refuting it.

Our research shows that James 3 (William 2, Thomas 1) Kidd is most likely the patriarch of a Buckingham County, Virginia Kidd family that does <u>not</u> include this James Kidd, nor his presumed brother Webb Kidd. See Appendix Five of this compilation for a summary of our research on the James 3 (William 2, Thomas 1) Kidd, using the Genealogical Proof Standard.

A descendant of this James Kidd (through his son Zachariah Kidd) is a member of the Kidd Y-DNA Project and is a close Y-DNA match to other known descendants of Thomas1 Kidd of Middlesex County, Virginia. Y-DNA evidence tells us that this Kidd line shares a common male ancestor, Thomas1 Kidd, with other Kidd lines. It does not, however, tell us how this Kidd line descends from Thomas1 Kidd.

1758 – The earliest record known for James Kidd in **Lunenburg County** is March 1758, when he had a claim for provisions in the French and Indian War: "To William Howard, Ephraim Hudson, and **James Kidd**, £1.5.6 each, providers of Provisions for Militia, French and Indian War."⁴⁵

James Kidd was a witness on 5 Sept 1758 when Mary Stevens⁴⁶ (Stephens) of Lunenburg County sold to John Cunningham of Lunenburg County a 200-acre tract of Lunenburg land, amount not noted. This tract of land was located along **Nutbush Creek** on the south side of the Roanoke River.⁴⁷ Mary Addaman Stevens was the mother-in-law of James Kidd, and left a bequest to his son William Kidd in her will written 4 Aug 1771 and proven 10 Oct

1791 in Mecklenburg County.48

Nutbush Creek was in the southeastern portion of Lunenburg County (the portion carved out of Lunenburg to create Mecklenburg county in 1764-1765). It coursed north from the North Carolina state line and flowed into the Roanoke River just beyond Coleman's Ferry. This area is now underwater in the John H. Kerr Reservoir, the large lake that was created by the building of the John H. Kerr Dam.

- 1758 During the French and Indian War, the House of Burgesses passed an act for the defense of the frontier of the colony on 14 September 1758. **James Kidd** was among the more than 225 soldiers from Lunenburg County named in the schedule attached to this act.⁵⁰
- 1761 On 21 Dec 1761, John Cunningham, county of Lunenburg, parish of Cumberland, sold to **James Kidd**, of same county and parish, 201 acres on **Nutbush Creek**, for 50£ recorded 3 Aug 1762. This is the same tract of land that John Cunningham purchased from Mary Stevens in 1758, above.⁵¹

Granville and Warren Counties, North Carolina lie to the south of Mecklenburg County, Virginia in this vicinity, just a few miles from James Kidd's land.

- 1762 On 2 August 1762, an indenture from John Cunninghame (sic) to **James Kid** (sic) was presented in Lunenburg County Court and recorded.⁵² This order likely relates to the 1761 sale above.
- 1763/64 This **James Kidd** and his family were in the portion of Lunenburg County that became Mecklenburg County in 1764; his sons James Kidd [Jr., also known as James H. or James Henry] and William Kidd attested that they were born in Mecklenburg County, VA in their Rev War pension applications [filed in GA in 1832 and 1833, respectively].⁵³ William, the elder son, was more likely born in Lunenburg County, before Mecklenburg County was created on 26 May 1764.
- 1764 In Lunenburg County Court on 9 February 1764, the case of John Potter, plaintiff, against **James Kidd**, defendant, on a petition was heard. For reasons appearing to the Court, the suit was dismissed at the Defendant's costs.⁵⁴
 - On 9 Aug 1764, Lunenburg County Road Orders record that John Johnson was appointed Surveyor of Road in the room of [succeeding] Chesley Daniel, from Kings Road to county line. The hands of Josiah Daniel, **James Kidd**, Miles Johnson, Joseph Michaux, John Stephens, and Thomas Stephens to work on said Road and keep it in repair according to Law.⁵⁵
- 1765 In February Court 1765 of Lunenburg County, Elizabeth Cuningham, widow and relict of James Cuningham, dec'd, came into Court and relinquished her right of dower in the land conveyed by her said husband to **James Kidd** and desired that the same might be recorded, which was ordered.⁵⁶

In April Court 1765 of Lunenburg County, **James Kidd**, a witness for Joseph Duprey against Richard Yancy, ordered to be paid for 4 days' attendance and for 25 miles travel each way from Carolina Line to the Old Court House, and once coming and returning 45 miles to this courthouse, and 2 shillings for ferriage. (Another witness, James Griffin, was paid for 45 miles travel from Mecklenburg County.)⁵⁷

In July Court 1765 of Lunenburg County, a similar notice as above to pay **James Kidd** for "Five days attendance and 3 times coming and returning 46 miles from Carolina Line and 2 shillings for ferriages.⁵⁸



Circa 1774 – The name of **James Kidd** appears on a list of colonial soldiers of Lunenburg County, "including rangers and militia" who served in the French and Indian War. No other Kidd citations in this book index.⁵⁹

No further records of **James Kidd** are found in Lunenburg County, because he lived in the portion that became Mecklenburg County in 1764.

1770 – 27 Aug 1770, **Mecklenburg County**, Virginia Land Office Patent to **James Kidd**, Patent Book 39, p. 105: 400 acres. On Keeth's [Keith's] Branch. Adjacent to land held by **James Kidd**. Boundaries: from Daniel Johnson's corner to **Kidd's corner** and "on his line" to Mrs. Stevens' corner on the "said branch" as it meanders to the beginning [Daniel Johnson's corner]. See Figure, below:



1771 – The will of Mary Stevens, signed on 4 Aug 1771 in **Mecklenburg County**, bequeathed land on Nutbush Creek to her **grandson William Kidd**, adjoining land of **James Kidd**. This will was proved in court on 10 October 1791.⁶²

NOTE: Mary Stevens was the widow of Thomas Addaman of Prince George County, VA

- and second the widow of Thomas Stevens of Brunswick County, VA. She owned more than 1000 acres in Mecklenburg County near the NC line.]
- 1775 On 14 January 1775, Giles Carter of Guilford County, NC sold to Robert Carter Jr. of Mecklenburg County for £35 about 200 acres in Mecklenburg County on the south side of Keeth's branch, it being all of the tract that Giles Carter purchased of Charles Carter, and where Robert Carter the elder now lives, and bounded by and between the lines of Daniel Johnson's orphans, Samuel Hopkins, Robert Burton Newton, John Hendrick, Thomas Stephens, and James Kidd...deed recorded 13 March 1775.63

Note: A John Kidd was listed as one of the adjoining landowners in a deed dated 11 October 1777 in which Mary Stevens sold one acre of land to John Johnson Jr. on south side of Nutbush Creek, same day that his father Michael Johnson gave him one additional acre adjoining the creek. We do not know the relationship, if any, of this John Kidd to James Kidd.

- 1777 In 1777 [no month or day listed]: **James Kidd and Winny his wife** [Winny/Winifred Hudson] of Mecklenburg County sold for (blank) £ to George Wilson of Bute County, NC, 100 acres bordered by the county line. No witnesses listed. Recorded 12 Jan 1778.⁶⁵
- 1779 On 8 Nov 1779, James Kidd served on a Mecklenburg County Grand Jury.⁶⁶
- 1780 In this year, according to his Revolutionary War pension application, William Kidd entered the militia of Virginia in Mecklenburg County for a second tour of 5 months, as a substitute for his father **James Kidd**, who had been drafted.⁶⁷
- 1781-1782 In the Mecklenburg County Court records pertaining to claims submitted for livestock, supplies, provisions, etc. supplied to the County or to the Continental Army during the Revolutionary War, James Kidd is mentioned several times:

 James Kidd, 1 cow, supplied 5 Sept. 8 Nov. 1781.⁶⁸
 - At a Mecklenburg County Court on 9 April 1782, **James Kidd** received a certificate for supplying 350# of beef.⁶⁹
- 1782, ff. A **James Kidd** appears on the Mecklenburg County Personal Property Tax Lists in 1782 (the first year for which these records are available) and reappears annually through 1796. (See Table below).

1783 – On 14 April 1783, Mary Stevens of Mecklenburg County sold for £225 a certain tract of land on which John Stevens now lives, containing about 199 acres, being part of a tract of 400 acres on which the said Mary Stevens now lives, and bounded by Nut Bush Creek and **James Kidd**. Signed − Mary (m her mark) Stevens. Witnesses to this deed were Michael Johnson, John Stevens, and John (X his mark) Johnson, Recorded 9 June 1783. ⁷²

1784 – On 24 Nov 1784, **James Kidd and Winney Kidd** his wife sold for £125 about 200 acres on Keiths Branch and bounded by Daniel Johnson's line, Wilson, and Stephens, to John Tanner. Witnesses included William (X his mark) Kidd, John Kindrick, and John Kindrick

Winney released her dower interest on 9 May 1785, the date that this deed was recorded. 73

Also in this year, their son James Henry Kidd moved to Georgia. James Henry Kidd married Elizabeth (last name unknown). In his pension application, James H. attests that he had been in GA since 1784. He lived in Elbert County, GA and researchers of this line can find deeds and other records in Elbert County.

- 1785 In a Mecklenburg County deed dated 26 December 1785, Hailey Johnson of Mecklenburg County sold for £120 to John Chas. Walden of Mecklenburg County about 400 acres in Mecklenburg County, bounded by **James Kidd's** new corner, the Country line, Burcett (Burchett), Keiths Branch. Recorded 9 January 1786. ⁷⁴
- 1787 On 17 February 1787, Robert Hudson of Mecklenburg County, Virginia signed his will. This will mentions "wife [not named]" and children Ephraim, "**Winney Kidd**," Mary Hudson, Lucy Kirles[?], William, Elizabeth Percies[?]. Grandson John Hudson. This will was proved April 11, 1796.⁷⁵

On 8 June 1787, Mary Stevens of Mecklenburg County sold "for love and affection" to William Kidd, a tract of land containing 200 acres on Nutbush Creek at the county line. This deed was recorded 11 Jun 1787.76

[Recall that this William Kidd was the son of **James Kidd Sr**. by his first wife, the daughter of Mary Addaman Stevens, whose given name is not revealed in the records.]

On 9 July 1787, **James Kidd** was one of the appraisers of the estate of Robert Carter, along with John Kendrick and George Freeman; they returned their appraisal to the Court on this date, and it was recorded.⁷⁷

- 1791 On 10 October 1791, the will of Mary Stevens was proved in Mecklenburg County Court and admitted to record.⁷⁸
- 1792 On 9 Jan 1792, in Mecklenburg County, an appraisal of the personal estate of Mary Stevens, dec'd, was made by **James Kidd**, John Hopkins, and William Kendrick. WB 3, p. 85.⁷⁹
- 1795 A marriage bond dated 8 Aug 1795 was issued in Mecklenburg County for **James Kidd** and Frances Robertson, surety Mark Robertson.⁸⁰ This bond includes the signature of this

- 1795 In a Mecklenburg County deed dated 11 Nov 1795, **James and Frances Kidd** of Mecklenburg County sold to William Hendrick for £180 a tract of land containing 222 acres, bounded by Nutbush Creek and lands of John Tanner and <u>William Kidd</u>. This deed was recorded 8 September 1800.⁸²
- 1796 In 1796, James Kidd drops from the Mecklenburg County PPTLs and, by 1798, he has moved to Oglethorpe County, GA:

- 1813 On 4 Oct 1813, **Anderson R. Kidd** sold this 119-acre tract to Pascal Murphy for \$300,⁸⁷ suggesting that Frances Kidd had died before this date.
- 1816 According to a letter from John P. Kidd to Murray Kidd dated 13 Jul 2001, **James Kidd** died in 1816 while living in Jackson County, GA, where his son John was also living, and the elder James may have been living with son John. However, on 13 April 1816, son James H. Kidd, of Wilkinson County, GA, applied to the Jackson County, GA court for letters of administration for the estate of **James Kidd**, deceased.

JAMES2 KIDD, aka James L. Kidd⁸⁸ – the son of George Kidd Sr. of Amelia County, VA James5 (George4, Benjamin3, William2, Thomas1 Kidd)
Born abt. 1767 in Amelia County, VA
Married Elizabeth Beasley before 1794, probably in Warren County, NC
Died 31 March 1842, most likely in Mecklenburg County, VA


We are now confident that this James Kidd was the father of John B. Kidd of Mecklenburg County, VA. Y-DNA evidence shows a close genetic match between a proven descendant of John B. Kidd and proven descendants of George Kidd Sr. of Amelia County, VA.

Records support this family connection: the Copy Book originally belonging to John B. Kidd, containing birth and death dates of the family, includes the date of death for his mother Elizabeth Beasley Kidd and a note that appears to be for the death year of his father James(2) Kidd.⁸⁹

This is also supported by the fact that a James Kidd appeared in Mecklenburg County, VA shortly before John B. Kidd did and later sold land to John B. Kidd, and John B. Kidd served as bondsman for the marriage of one of James Kidd's daughters, Elizabeth Ann Kidd, to Riddick/Roderick Temple. Consent was given by **James L. Kidd**, father of Elizabeth.⁹⁰

1788 – The Amelia County Virginia Personal Property Tax Lists reveal that in this year George Kidd Sr. had two white males of taxable age, Lod. and Jas., in his household.⁹¹



This is the earliest record mentioning this James Kidd by name.

1789-1792 – In each of these years, the above 1788 entries were repeated: Taxpayer White male tithes

1798 - A **James Kidd** witnessed the will of John Brewer in Dinwiddie County, VA on 4 October 1798. This is likely the same James Kidd, since Usley Kidd, George Kidd Sr.'s daughter [and thus sister to James], married John Brewer in Amelia County, VA on 16 April 1794. We have not found any other James Kidd in Amelia or Dinwiddie Cos in this time period.

When and where James Kidd married his wife Elizabeth Beasley is uncertain. No record of their marriage is found in Warren County, NC, and none is found in Mecklenburg County, VA or in Amelia County, VA. He disappears from Amelia County after 1791/2, and likely married Elizabeth around this time in Warren County, NC.

The early annual tax lists (prior to 1800) for Warren County, NC are incomplete, judging from the years that have been microfilmed by the Family History Library. Many of the lists that have survived are fragmentary, and some are unalphabetized and out of chronological order. We find no evidence of James Kidd in Warren County until 1800.⁹²

1800 – The first record we have of this **James Kidd** in Warren County, NC is his entry on the 1800 Census. In this listing, he's 45 years or older, with a woman (likely his wife Elizabeth) age 26-44, and one male, less than 10 years old (likely his son John B.). This enumerated age is suspect, given the age of his wife; it's more likely that he too was 26-44 at the time of this census.

On 12 March 1800, **James Kidd** served as bondsman to Allen Burton who married Elizabeth Brooks in Warren County, NC.⁹³

1804 – On the 1804 PPTLs for Mecklenburg County, VA, List B, a **James Kidd** appears for the first time since 1795, taxed for 1 white male tithe and 1 horse. ⁹⁴ No other Kidd males appear on either of the Mecklenburg PPTL lists in 1804. His name drops from the Mecklenburg PPTLs in 1805, and no Kidds are found on the Mecklenburg PPTLs again until 1816 (see below).

We believe that this citation most likely belongs to this James Kidd, who evidently resided very close to the VA-NC state line, judging from the records below.

1805 – **James Kid** is named in the 1805 Warren County, NC division of the lands of his father-in-law John Pitts Beasley, who died in 1792. James receives his wife Elizabeth's share of her father's estate: 69 acres lying on the branches of Hawtree (Creek). Hawtree Creek lies in northern Warren County, flowing north to empty into the Roanoke River (and what is now Lake Gaston) in the southeastern corner of Mecklenburg County, VA.

This division was prompted by the marriage of John Pitts Beasley's widow Elizabeth to

Abraham Puckett.

James Kidd also served as bondsman to the marriage of his mother-in-law Elizabeth Beasley to Abraham Puckett in Warren County, NC on 27 May 1805.⁹⁶

On 16 December 1805, in Warren County, NC, **James Kidd** was named in an account of sale of the estate of John Pitts Beasley, deceased.⁹⁷

- 1807 On 11 Nov 1807, **James Kidd** was the bondsman for the marriage of his brother-in-law Pitts Beasley to Martha Acree in Warren County, NC.⁹⁸
- 1808 **James Kid** first appears on the extant Warren County tax lists in 1808, in the Six Pound District,⁹⁹ taxed on the 69 acres inherited from John Pitts Beasley, his father-in-law. He's taxed for one white poll and no black polls.

As seen in the map below, the Six Pound district is in the north-central portion of Warren County, just below the NC-VA state line.



1810 – On 13 March 1810, William Kimball of Warren County, NC sold to James Kidd of the same place for \$150 a tract of 50 acres of land in Warren County, lying on Six Pound (Creek) and adjoining Thomas Beasley's line. This deed was proved in Warren County Court in its February 1811 Term.¹⁰⁰

James Kidd does not appear on the 1810 Census anywhere in North Carolina, and the 1810 federal census is not extant for Mecklenburg County, VA.

However, the records below suggest he remained in North Carolina.

1811-1815 – James Kidd appears on the Warren County, NC tax lists in these years, as follows: 101

We have not been able to locate subsequent tax lists for Warren County, to see if he appears on the tax lists for 1816.

- 1816 Sometime in 1816, **James Kidd** moved to Mecklenburg County, VA, just over the state line from Warren County, NC. The family may not have traveled far; several of John B. Kidd's children later married in Warren County, NC, suggesting that they lived very near the state line. Another possible explanation, offered by Wayne Rainey, is that "the Kidds, like many other families of the southeastern part of Mecklenburg County, VA, married in neighboring Warren County mostly because the Warren County courthouse was closer than the one in [Mecklenburg's county seat] Boydton, Virginia, plus after the railroad came in, it was very much closer, as the railroad went into Warrenton, NC," the county seat of Warren County.
- 1816 On 24 January 1816 in Mecklenburg County, VA, James Kidd of Warren County, NC entered into a Deed of Trust with James Critchlow of Brunswick County, VA, in order to obtain the purchase price for a 500-acre tract in Mecklenburg County, purchased from Winnifred Winn for \$500.¹⁰²

On the same date, Winnifred Winn of Mecklenburg County, VA sold to James Kidd of

Warren County, NC for \$500 the above-described tract in Mecklenburg County, VA. Both deeds were recorded in the Mecklenburg County Clerk's office on 17 October 1821. 103

1816 – After a hiatus of 12 years, a **James Kidd** again appears on the Mecklenburg County, VA PPTLs (see Table below). A William Beasley appears on these PPTLs the year prior; likely James Kidd's brother-in-law, he is a man of similar taxable wealth, and both appear to have moved north across the NC-VA state line from Warren County, NC. James Kidd continued to appear annually on these lists through 1822.

In 1823, James Kidd's name drops from the Mecklenburg County PPTLs, and his son, John B. Kidd, is listed in his place, with the number of slaves over 12 and of livestock remaining essentially the same. We conclude that they most likely lived together, and that John B. Kidd began to take more of the head of household role in 1823. John B. continued to be listed as the taxpayer in 1824 and 1825.

In 1826, John B. Kidd is not listed, and the taxpayer was "L. James Kidd." For some reason, James Kidd is listed instead of John B. this one year. This is the last appearance of James Kidd on the Mecklenburg PPTLs.

1816-1827 – **James Kidd** also appears on the Mecklenburg County Land Tax Lists in 1816, when he is taxed on 500 acres, valued at \$250. In this entry, he's listed as "James Kidd Sr." In 1817, this parcel of land is described as "west side, Great Creek, 14.8 miles from Courthouse".

[NOTE: Great Creek is in the southeastern part of Mecklenburg County, flowing south to the Roanoke River and lying just east of the community of Maringo; it is less than two miles

west of the Mecklenburg-Brunswick county line, which it parallels. It is visible on sections 12 and 16 of the 1870 map of Mecklenburg County, coursing past the lands of William Reany/Rainey and "Mrs. Kidd's."

Hawtree and Six Pound Creeks in NE Warren County are directly across the Roanoke River from Great Creek, less than ten miles to the south. Thus, James Kidd did not move far when he left Warren County.]

In 1820, he's taxed on 510 acres, "east and west sides of Great Creek," and a \$240 evaluation was added for buildings. In 1822, his entry describes revenue returned to **James Kidd**, "debit for too much charged," and his acreage drops back to 500 acres.

These entries repeat annually through 1827, when he sold this land to his son John B. Kidd.

- 1820 On the federal census in Mecklenburg County, VA, p. 33, line 13:

 James Kidd: 1M 16-25 & 1>44; 2F<10, 1 10-15, 1 16-25 & 1>44. Three slaves. Three individuals in agriculture.
- 1825 On 20 July 1825, Elizabeth Ann Kidd and Riddick [Roderick] Temple obtained a marriage bond, surety John B. Kidd, her brother, consent by her father **James L. Kidd**. ¹⁰⁶
- 1827 In a deed dated 3 March 1827, **James Kidd** sold a tract of land adjoining Presly Hinton, James Carrol, Charles Jones, and the estates of John Martain and William Jones, containing 500 acres, to John B. Kidd of Mecklenburg County for \$500. This deed was recorded the same day.¹⁰⁷

In a deed dated 25 August 1827, John B. Kidd and Betsy M., his wife of Mecklenburg County, sold to Roderick Temple of Brunswick County, "For and in consideration of the love and affection for Roderick Temple our brother-in-law and for \$1," a tract of land on Charles Jones line, a sweet gum on Great Creek, along Jones' line to Hunters Mill pond, etc., and containing 198½ acres. Signed and sealed by John B. Kidd; signed with mark by Betsy M. Kidd.

James Kidd and Sally Griffith witnesses.

On 30 March 1833 the justices of the peace certify that Kidd personally acknowledged the deed and that Betsy relinquished her dower rights. Deed recorded 15 April 1833.¹⁰⁸

It appears that this land conveyed by John B. Kidd to his brother-in-law Roderick Temple in August 1927 was part of the larger tract that James Kidd had sold to John B. Kidd a few months earlier in March 1827. Since John B. Kidd and Elizabeth, wife of Roderick Temple, are the only known children of James Kidd, these transactions may represent James Kidd's transfer of his property to his heirs.

No further mention of this **James Kidd** is found in Mecklenburg County, VA records, to our knowledge. We have not found him on the 1830 federal census; we've found his two known children John B. Kidd and Elizabeth Kidd Temple, and there is no older white male who could be their father in either household.

1840 – no James Kidd appears by name of the 1840 federal census in Mecklenburg County, VA. In 1840, John B. Kidd headed the only Kidd household in Mecklenburg County. ¹⁰⁹ In his household was an older male, age 60-69, who likely is his father James Kidd.

No will has been found in Mecklenburg County, VA for James Kidd. According to the Copy Book of John B. Kidd: "James L. Kidd died in 1842." ¹¹⁰ Because the only other death recorded in the Copy Book is that for Elizabeth Kidd (James' wife Elizabeth Beasley), we feel sure that this is the date of death for his father James L. Kidd. John B. Kidd also had a son named James L. Kidd, but this son was alive at the time of the 1850 federal census and so did not die in 1842.

JAMES HENRY KIDD, the son of James(1) Kidd and his second wife Winifred/Winny Hudson

Born about 1764 in Mecklenburg County, VA Migrated to Georgia in 1784 Died after September 1840 in Georgia

What we know of James H. Kidd's life in Virginia comes from his Revolutionary War pension application, in which he states he was born in 1764 in Mecklenburg County, VA. The application contains his signature "Jas H Kidd." See <u>Appendix Three</u> for a transcription of this application.

- 1779-1781 **James H. Kidd** served for several tours of militia duty, one alongside his brother William Kidd, according to their Revolutionary War pension applications.
- 1784 In his pension application, **James H. Kidd** states that he "removed from Virginia to Georgia in 1784."
- 1785 On 4 January 1785, **James Henry Kidd** was issued a Land Warrant in Wilkes County, GA for 400 acres on Beaver Dam Creek.¹¹²
- 1833 His pension application was filed 13 Aug 1833 in DeKalb County, GA, when he was aged 68. His brother William Kidd signed an affidavit in Oglethorpe County, GA 15 Sept 1832 stating that he served with his brother **James H. Kidd** in the Virginia militia "in the year in which the Battle of Guilford was fought [1781]."

- 1838 **James H. Kidd** appears on the 1835 list of Revolutionary War pensioners in Jackson County, GA, aged 69, for service in the Virginia militia.¹¹³
- 1831-1847 **James H. Kidd** appears on the Georgia Revolutionary War pension pay rolls during this period, with the last payment noted in September 1840.¹¹⁴

Many more records for James Henry Kidd can be found in Georgia.

No further records for this John Kidd have been found in Mecklenburg County, VA to our knowledge.

1810 – In an Oglethorpe County, GA deed dated 10 June 1810, James Kidd conveyed to Frances Kidd, "his loving wife," a life estate on 119 acres on headwaters of Grove Creek in Oglethorpe County, GA, a Negro slave Jenny, and household items. Upon the death of Frances Kidd, all this property to go to "my son" Anderson R. Kidd. Also additional property to go to Anderson R. Kidd, including four year old male slave Shadrack. If Anderson R. Kidd should die without heirs, then all the above property is to go to "my son" John Kidd and his heirs. On 4 October 1813, Anderson R. Kidd sold this 119-acre tract to Pascal Murphy for \$300,117 evidence that Frances Robertson Kidd had died before this date.

He may be the **John Kidd** whose will was written 23 Dec 1833 and proven in March term 1834 in Oglethorpe County, GA.¹¹⁸

- for the marriage of one of James Kidd's daughters, Elizabeth Ann Kidd, to Riddick/Roderick Temple. Consent was given by James L. Kidd, father of Elizabeth.¹²⁰
- 1800 **John B. Kidd** is likely the young male listed in the household of James Kidd in the 1800 Warren County, NC census, with one male 45 years or older, one female (likely his wife Elizabeth) age 26-44, and one male, less than 10 years old (likely his son John B.). (At the time of this census, James Kidd was likely 26-44, not 45 or older.)
- 1818 A marriage bond for **John Kidd** and Betsy M. Rainey was issued 16 February 1818 in Mecklenburg County, VA. The surety was William Rainey, and Williamson Rainey Sr., father of Betsy, gave his consent.¹²¹
- 1820 The 1820 federal census has only one Kidd household, that of James Kidd, in Mecklenburg County, VA; **John B. Kidd** is likely the young man listed in the household of James Kidd (p. 33, line 13):

 James Kidd: 1M 16-25 & 1>44; 2F<10, 1 10-15, 1 16-25 & 1>44. Three slaves. Three individuals in agriculture.
- 1823 From 1816 through 1822, James Kidd was the only Kidd taxpayer found on the Mecklenburg County PPTLs. In 1823, James Kidd drops from the PPTLs, replaced by his son **John B. Kidd** (listed as John Kidd), with a similar number of slaves and horses to those found under James Kidd in earlier years. John B. Kidd continued to be listed each year as either B. John or John B. Kidd through 1850, the last year we've checked. The sole exception occurred in 1826, when John B. Kidd is NOT found on the PPTL that year, but an "L. James Kidd" is listed. We believe that in the period from 1823 through 1827, John B. Kidd was gradually assuming the role of household head, taking over for his aging father. In his Copy Book, John B. Kidd referred to his father as "James L. Kidd."

1825 – John B. Kidd served as surety for the Mecklenburg County, VA marriage bond issued 20 July 1825 for his sister Elizabeth Kidd and Riddick Temple. Consent was given by James L. Kidd, their father. 126

1827 – In a deed dated (blank) January 1827, Samuel Jones of the County of Rutherford, State of Tennessee, and Mary Jones, his wife, "who holds a life estate in the land" sold to **John Kidd**

of Mecklenburg County, VA a tract of 50 acres. This deed was signed by mark of Samuel Jones and Mary Jones. Justices of the peace certify that Samuel Jones appeared in person to acknowledge the deed and that Mary relinquished dower rights. This deed was recorded 20 August 1827.¹²⁷

In a deed dated 3 March 1827, James Kidd sold a tract of land adjoining Presly Hinton, James Carrol, Charles Jones, and the estates of John Martain and William Jones, containing 500 acres, to **John B. Kidd** of Mecklenburg County for \$500. This deed was recorded the same day. 128

In a deed dated 25 August 1827, **John B. Kidd** and Betsy M., his wife of Mecklenburg County, sold to Roderick Temple of Brunswick County, "For and in consideration of the love and affection for Roderick Temple our brother-in-law and for \$1," a tract of land on Charles Jones line, a sweet gum on Great Creek, along Jones' line to Hunters Mill pond, etc., and containing 198½ acres. Signed and sealed by **John B. Kidd**; signed with mark by Betsy M. Kidd. James Kidd and Sally Griffith witnesses.

On 30 March 1833 the justices of the peace certify that Kidd personally acknowledged the deed and that Betsy relinquished her dower rights. Deed recorded 15 April 1833.¹²⁹

It appears that this land conveyed by John B. Kidd to his brother-in-law Roderick Temple in August 1927 was part of the larger tract that James Kidd had sold to John B. Kidd a few months earlier in March 1827. Since John B. Kidd and Elizabeth, wife of Roderick Temple, are the only known children of James Kidd, these transactions may represent James Kidd's transfer of his property to his heirs.

This deed wasn't recorded until 1833, and perhaps this is the explanation as to why John B. Kidd continued to be taxed on 550 acres in Mecklenburg County through 1830 (see below).

- 1828-1830 **B. John Kidd** appears for the first time on the Mecklenburg County, VA Land Tax Lists in 1828, taxed for two parcels of land.
 - 1) 500 acres, east and west sides of Great Creek, from James Kidd; and
 - 2) 50 acres on Great Creek, from Samuel and Mary Jones.
 - These entries repeat in 1829 and 1830, the last year that we've examined so far.
- 1830 He appears on the 1830 federal census in Mecklenburg County, VA, part 2, page 58: **John D. (sic) Kidd** one WM<5, 3 5-9, & 1 30-39; 1F 5-9, 1 10-14 & 1 30-39 and 1 60-69. Ten slaves. The identity of the older white woman is unclear. 130
- 1833 On 30 August 1833, **John B. Kidd** and his wife Betsy M. sold 50 acres of land in Mecklenburg County to Elizabeth Wall for \$110, bordered by Barber and Z. Jones corner,

- along Jones line, along Rubin Haenia's (?) line. This deed was signed and sealed by John B. Kidd; Elizabeth M. Kidd signed with an X.
- That same day, John B. Kidd acknowledged the deed to be his own, and Elizabeth Kidd relinquished her dower right to the land. The deed was recorded 10 February 1834. ¹³¹
- 1834 In a deed dated 8 December 1834, Thomas Palmer of Northampton County, NC sold a parcel of land containing 310 acres to **John B. Kidd** of Mecklenburg County. This deed was recorded 19 January 1835. 132
- 1840 In 1840, John B. was the only Kidd household head in Mecklenburg County, VA.¹³³ **John B. Kidd**: 2M<5, 1 10-14, 2 15-19, 1 40-49 AND 1 60-69 (likely his widowed father James Kidd); 3F 5-9, 2 15-19 & 1 30-39. Eleven slaves.
 - On 3 November 1840, Benjamin Taylor of Mecklenburg County, VA sold to **John B. Kidd** of the same place for \$718.50, a tract of land in Mecklenburg County,, adjoining the lands of John B. Kidd, Isaac Cole and others, and containing by survey 266½ acres. This deed was proved in court on 16 November 1840 and admitted to record.¹³⁴
- 1841 On 12 January 1841, James M. Harwell, Commissioner of Mecklenburg County, VA sold to **John B. Kidd** of the same place for \$714, a tract of land known as the estate of John and Luraney Griffis(?), dec'd, supposed to contain 140 acres, bounded on the west by Great Creek, on the north by the lands known as Blanton's Mill Tract, on the east by lands of David Thomas, and on the south by lands of John B. Kidd and the estate of Saml. McKinny. This deed was recorded 15 March 1841. 135
- 1846 The Mecklenburg County, VA will of Williamson Rainey, signed on 8 Jan 1846, bequeathed two slaves and other property to his daughter "Elizabeth M. Kydd," the wife of **John B. Kidd.** ¹³⁶
- 1850 In this year, the number of **John B. Kidd**'s tithables drops, and two new Kidds appear on the Mecklenburg PPTLs; these are his sons Bartlett M. and James L. Kidd. See their sections in this paper.
- 1850 On the federal census in Mecklenburg County, VA, 98th Regiment, p. 59A, HH 167/167: **John B. Kidd** 58M farmer \$5245 VA

1862 – **John B. Kidd** died September 1862 in Mecklenburg County, VA.¹³⁷ His will, dated 12 Jun 1862, left bequests to his wife Betty M. Kidd and to their children.¹³⁸

On 15 September 1862, Peter M. King entered into an executor's bond in the sum of \$20,000 for John B. Kidd's estate.¹³⁹

John B. Kidd's estate was appraised on 11 November 1862. The appraisal was returned to court and admitted to record on 19 January 1863; it included thirteen slaves. 140

1863 – An account of the sale of his property was returned to Court and recorded on 16 March 1863.¹⁴¹

1864 – The final account of his estate was admitted to record on 16 May 1864. 142

JUDITH (CARTER) KIDD, daughter of Thomas Carter of Mecklenburg County, VA, and wife of William Kidd of Mecklenburg County, VA and Oglethorpe County, GA

- 1781 On 8 October 1781 in Mecklenburg County, VA, William Kidd entered into a marriage bond, with Simon Williams as his security, for his intended marriage to **Judy Carter**. William Kidd signed this bond with an X.¹⁴⁵
- 1795 The Mecklenburg County, VA will of Thomas Carter names wife Mary and sons John, Charles, Thomas, daughter Elizabeth Johnson, "daughter **Judith Kidd**," Sally Johnson, Mary Freeman. Secretary [?] Carter and Sarah Carter, by Robert Carter [likely minor children]. Among his bequests were "ITEM: I give and bequeath to my daughter, Elizabeth Johnson, one Negro named Milley. I give and bequeath unto my daughter, **Judith Kidd**, one Negro called Cato." This will was signed 21 December 1795, and recorded 8 August 1796. ¹⁴⁶

More information about Judith can be found in the section for her husband William (below).

- **LEWIS KIDD** The only records for this man are found in Lunenburg County, the parent county for Mecklenburg County, formed 26 May 1764 from Lunenburg. He is included here because a James Kidd was also in Lunenburg County at this time, and it's possible, but not proven, these two men were somehow related.
- 1764 **Lewis Kidd** appears on the 1764 Lunenburg County PPTL, with 1 tithe and no land to be taxed. 147

We do not know who this Lewis Kidd is, but the book "Property Lines from An Old Survey Book, Halifax County, VA, 1741 to 1901," by Roger C. Dodson, 1987, VA-NC Piedmont Genealogical Society, contains a survey recorded 2 Oct 1765 for a **Lewis Kidd**, for 337 acres on Aaron's Creek (a tributary of the Dan River). Bounded by surveys of John Sizemore, Thomas Loftis, William Gill, Henry Stafford (his survey done 1 Oct 1765). This land is on the Mecklenburg County line. 148

REBECCA J. (KIDD) CANNON, the daughter of John B. Kidd and Elizabeth M. Rainey Born 10 December 1818¹⁴⁹ in Mecklenburg County, VA Married Archibald Cannon in 1844 Died in Mecklenburg County in 1897

1844 – On 23 Dec 1844, Archibald Cannon entered into a marriage bond in Mecklenburg County, VA for his marriage to **Rebecca J. Kidd**. The surety was Roderick Temple. The ceremony was performed by Minister James McAden.¹⁵⁰

Rebecca is found on the U.S. Federal censuses with her husband and children in Mecklenburg County in 1850, 1860, 1870 and 1880.

1897 – She died sometime in 1897. She had signed her will in Mecklenburg County on 4 March 1889; it was proved in Court on 19 April 1897. Her son, Willis Cannon was appointed administrator, since she did not name an executor in her will.¹⁵¹

1763 – **William Kidd** was born 16 December 1763 in Mecklenburg County, VA, according to his Revolutionary War pension application, although he may have been born in Lunenburg County, from which Mecklenburg County was formed in 1764. He served several terms in the Revolutionary War, one term as a substitute for his father, and received a pension for his service. His pension application is the source of additional information we have about him. See Appendix Three for a transcription of this application.

- 1784 On 24 November 1784, James Kidd and Winney Kidd his wife sold for £125 about 200 acres on Keiths Branch and bounded by Daniel Johnson's line, Wilson, and Stephens, to John Tanner. Witnesses included **William (X his mark) Kidd**, John Kindrick, and John Kindrick Jr.
 - Winney released her dower right on 9 May 1785, the date that this deed was recorded. 156
- 1787 On 8 June 1787, Mary Stevens of Mecklenburg County conveyed to **William Kidd**, "for love and affection," a tract of land containing 200 acres on Nutbush Creek at the county line. This deed was recorded 11 June 1787.¹⁵⁷
- 1778-1781 **William Kidd** served several tours of duty in the Revolutionary War, one alongside his brother James H. Kidd, according to his Revolutionary War pension application. ¹⁵⁸
- 1791 The Mecklenburg County, VA will of Mary Stevens names son Thomas Addaman, daughter Mourning Matthews, grandson **William Kidd**, and sons John and Thomas Stevens. Her will was signed 4 August 1791 and recorded 10 October 1791. Mary Addaman Stevens was the mother of James(1) Kidd's first wife, who was an Addaman and the mother of their son **William Kidd**. This wife evidently died at or soon after childbirth. See records for James(1) Kidd, above.

- give and bequeath unto my daughter, **Judith Kidd**, one Negro called Cato." This will was signed 21 December 1795, and recorded 8 August 1796. 160
- 1797 On 21 August 1797, **William and Judy Kidd** of Mecklenburg County sold to John Tanner of the same place for £200 a tract of land containing 200 acres on the county line, formerly belonging to Mary Stevens. This deed was recorded 9 Apr 1798. ¹⁶¹
- 1798 On 9 June 1798, **William Kidd** of Mecklenburg County sold to Nathaniel Chamblis 150 acres on Nutbush Creek, for \$100. This deed was recorded on 8 Oct 1798. 162
 - On 1 September 1798, James Kidd of Oglethorpe County, GA granted power of attorney to "my son **William Kidd"** to sell land in Mecklenburg County, VA. This power was recorded on 8 October 1798, the same date as the deed cited above.¹⁶³
- 1799 **William Kidd** drops from the Mecklenburg County, VA PPTLs and does not reappear. This is consistent with his Revolutionary War pension application, in which he states that he moved to Oglethorpe County, GA in 1799.
- 1832 -- On 4 Sept 1832, William Kidd gave an affidavit for his Revolutionary War pension application in Oglethorpe County, GA. He gave his age as 69 and signed his application with his mark (X).¹⁶⁴

WINIFRED (HUDSON) KIDD, the daughter of Robert Hudson of Mecklenburg County, VA, and second wife of James(1) Kidd. With James, she likely had at least four children: Anderson R., James Henry, Zachariah, and John Kidd Married James(1) Kidd before 1787 Died before August 1795, when James(1) Kidd married Frances Robertson

- 1777 In 1777 [no month or day listed]: **James Kidd and Winny his wife** of Mecklenburg County, VA sold for (blank) £ to George Wilson of Bute County, NC, 100 acres bordered by the county line. No witnesses listed. This deed was recorded on 12 January 1778. ¹⁶⁶

1787 – **Zachariah Kidd** first appeared on the Mecklenburg County, VA PPTLs in 1787, in the household of his father James Kidd. He continued to be listed there annually through 1789, then drops from the Mecklenburg County PPTLs until 1795, when he appears this one year only. No further record of him is found in Mecklenburg County, VA to our knowledge.

- 1794 On 24 November 1794, Herrod Thornton and Phebe his wife of Oglethorpe County, GA sold to **Zachariah Kidd** of the same place for £30 a parcel of land in Oglethorpe County containing 200 acres.¹⁷⁵
- 1795 In the spring of 1795, he again appears on the Mecklenburg County, VA PPTL (see above), and sometime soon after that he evidently returned to Oglethorpe County, GA, where, on 25 June 1795, a marriage record is found for **Zachariah Kidd** to Sally Sorrow in Oglethorpe County, GA. 176
- 1804 **Zachariah Kidd** died before 18 January 1804, when the Oglethorpe County Court of Ordinary bound Henry Sorrow for the sum of \$1500 and appointed him as the administrator of the estate of **Zachariah Kidd, deceased**. The Court at that time also appointed Commissioners to make an inventory of the estate. Henry Sorrow may have been the brother of Zachariah's wife Sally Sorrow.

A descendant of Zachariah Kidd, the son of James(1) Kidd, is a participant in the Kidd Y-DNA project and is a close genetic match to other proven descendants of Thomas Kidd, who died in 1680 in Middlesex County, VA.

This is the same book that Judy Tudor refers to as the Baisey Book, because it was passed down to Etta Gertrude "Gertie" Kidd, the great-great granddaughter of John B. Kidd; she married Dillard B. Baisey, and the copy book then went to her daughter, who married a Hall. An alternative provenance of this copy book is that it went to John B. Kidd's daughter, Elizabeth Kidd, who married Miles Hall. This is actually a better explanation for the passing down of the copy book, although it doesn't explain why Judy calls it the Baisey Book. Her note on the large scroll she prepared says that this book was "left at Hunt Club in 1992."

On this thirteenth day of August in the year eighteen hundred & thirty three personally in open court before Hudson H Allen, Jesse A Reeve, N Akers, G Vanwilkingburgh Esquires, Justices of said Inferior county court James H Kidd a resident of the county of DeKalb and State aforesaid aged sixty eight years who being first duly sworn according to Law doth on his oath make the following declaration in order to obtain the benefit of the provision made by the act of Congress passed June 7th 1832 That he the said James H Kidd was drafted in the militia of Virginia and entered the service of the United States in the month of January in the year 1779 as a private in the company commanded by Capt Reuben Vaughn [Reuben Vaughan] & served in the regiment commanded by Col. Lewellen Burwell the General under whom he first served was Gen Francis Mason whom he joined at Granville Court house North Carolina he was then marched by the way of Hillsborough, Salisbury, & Charlotte in North Carolina & Camden in South Carolina & joined General [Benjamin] Lincoln at Bacons Bridge near Charleston S.C. was in a skirmish near the place and afterwards in the battle of Stono [Battle of Stono Ferry, 20 Jun 1779], he was then marched back to Virginia & discharged by Capt. Vaughn in the month of July having served at this time a six months tour but his discharge has been long since lost. From his desire to go in the army he reported himself old enough to be put on the Militia roll which was done and he was in a few days after drafted for the above service and entered the army at about fifteen years of age, he was born & raised, & entered the service in every instance during the revolutionary war in the county of Mecklenburg State of Virginia

He knows of no living witness by whom to establish the above mentioned service except Ansel Cunningham [pension application S31636] whose affidavit is hereto attached, it being the only way in which it could be furnished it being out of the power of this declarant to get him to attend court he living a great way off and being very old & infirm—

In the year 1780 he was again drafted as a private for a three months tour of Duty in the Virginia Militia & marched under the command of Captain John Kendrick from Mecklenburg to Williamsburg in Virginia & was then ordered back how long he served this term he does not know precisely but he knows not less than two months, this part of the service he does not rely on not being able to give the time of service exactly—

Again in the year seventeen hundred & eighty one he Volunteered in the County of Mecklenburg in of Virginia & served a three months tour of duty commencing in January & ending in April in the company commanded by Captain John Brown whose company was attached to the regiment commanded by Col. Robert Muntford [sic: Robert Munford] & Major [St. George] Tucker. The regiment joined the command of General [Robert] Lawson at Skipwiths ferry on the roanoak river [sic: Roanoke River, possibly near present Skipwith in Mecklenburg County VA], after which he with Gen Lawsons command joined Gen. [Nathanael] Greene at haw river in North Carolina, he was at the battle of Guilford [Guilford Courthouse NC, 15 Mar 1781] & afterwards at Ramsey's Mill on the deep river & was then detached as Guard or part of guard and sent with prisoners to

Albemarle Courthouse in Virginia & was then marched back to Mecklenburg & discharged by Capt Brown. After his discharge, the company was to draw some salt at which time they were required to present their discharges, in order to show their right to draw he presented his discharge & never received it back and it was lost to him, he knows of but one person by whom he can prove the last mentioned service whose evidence is herewith furnished the name of that witness is William Kidd [S31796] And deponent further states that he has no record of his age, that he was born in the year 1764 – that he removed from Va to Georgia in 1784 & has resided in various Counties in Geo till this time & that he now resides in Dekalb County And deponent would state the names of Archibald Hamilton and Joseph Thompson Esq &c who can testify to their belief of his [word illegible]

& he hereby relinquishes every claim to a pension or an annuity except the present & he declares that his name is not on the pension roll of any agency in any State or territory

On this fourth day of September eighteen hundred & thirty two personally appeared in open Court before the Justices of the Inferior Court while sitting for ordinary purposes, William Kidd a resident of the county & state aforesaid aged nearly sixty nine years who being first duly sworn according to law, doth on his oath make the following declaration in order to obtain the benefit of the act of Congress passed the 7th June of the present year entitled "an act supplementary to the act for the relief of certain surviving officers & soldiers of the Revolution." That he entered the American service in the Revolutionary struggle under the following named officers & served as herein after stated. That he was born in Mecklinburg [sic: Mecklenburg] county in Virginia on the 16 th December 1763, according to the account handed down to him by his parents, there being no record of his age as far as he knows – That he lived in Mecklinburg when he entered the militia service in the revolutionary war, & lived there until he moved to Georgia in 1799, & settled in Oglethorpe county where he has lived ever since & where he now lives. That when he was near fifteen years old – to wit in the summer of 1778– being well grown of his age he was employed as a substitute in the place of one William Perry for a tour of five months military service in the Revolutionary was against Great Britain — he was received as a substitute & performed the whole tour under the command of General Lewis [see endnote] & Captain Anderson- he marched first to Portsmouth & then to Turkey Point not far from Baltimore & his only duty during the expedition was simply marching & guarding — he had no battle & not so much as a skirmish — when the time expired he was discharged at Portsmouth, but has lost his discharge.

In the year 1780, he performed another tour of military service in the militia of Virginia, of five months duration, as a substitute for his father James Kidd, who had been drafted for that length of time. He left home this trip he thinks in the month of May. During this tour he marched to Hillsborough in North Carolina under the command of Captain Benjamin Ferrel his regiment (the number of which he does not now recollect) was commanded by Colonel Lukes or Lucas [James Lucas]. From Hillsborough he marched to the Gum swamp near Camden South Carolina, when under General [Horatio] Gates he was defeated by Cornwallis & Tarlton [sic: Lt. Col. Banastre Tarleton; Battle of Camden, 16 Aug 1780] – During this engagement he was severely wounded by a cut on the left shoulder which he received from the sword of the enemy. His post in this battle was among the regulars on the right wing of the army — the evening before the battle the following plan was formed, which was executed the next day. Four men were selected out of the company of each militia captain so as to correspond with the number of regulars, & these select militia men & regulars were placed alternately along in the right wing of the army & of this number deponent was one [see endnote]. He fought in the Brigade commanded by General Stephens [sic: Edward Stevens]. Being defeated he retreated to Charlotte & thence to Hillsborough. Deponent was carried home, where he received a permit to remain until he had sufficiently recovered, from under the hand of Colonel [Robert] Munford, which will appear by reference to a small document hereunto annexed & marked A. which together with such further testimony as deponent may be enabled to obtain in support of

his claim before its final adjustment at the War Department, he respectfully prays may be taken & considered as a part of this his Declaration. His time expired before he got well enough to march & he never received a discharge from this campaign.

In 1781, he volunteered for seven weeks, under the command at first of Captain Swepston [possibly Richard Swepson] & after a little while he joined a corps of rifle men under the command of Captain Brown [probably John Brown] — he does not recollect the precise date of the beginning or end of this short tour; but he knows that he was in the Battle of Guilford during its continuance – his principle officer here was General [Nathanael] Greene – he belonged to General [Robert] Lawson's Brigade and Colonel Munford's Regiment – his situation in this Battle was in the right wing of the army. He was discharged from this tour near Deep River in N. Carolina, but has lost his discharge. He thinks he can establish this last tour by his brother James Kidd [James H. Kidd, pension application S16436] who was with him when it was performed & whose testimony he will endeavor to obtain before his claim is presented for final adjustment. His neighbours are the honorable William H. Crawford, Major Joseph J. Moore, Robert Freeman Esquire, Richard Gregory [31712], & Charles Carter [S31593], the two last of whom are reputed to be soldiers of the Revolution & others, any of whom he doubts not will cheerfully establish his character as a man of honesty & truth. He hereby relinquishes every claim whatever to a pension or annuity except the present, & declares that his name is not on the pension roll of the agency of any State in the Union.

NOTES: The only known General Lewis from Virginia was Andrew Lewis, who resigned on 15 Apr 1777. Kidd's account of the mixing of regular soldiers and militiamen in the line at the Battle of Camden is apparently not found elsewhere.

APPENDIX FIVE: Was James Kidd of Slate River the Father of Moses Kidd of Buckingham County, Virginia, and His Siblings? And Who Was This James Kidd?

Buckingham County was created in 1761 from Albemarle County. In 1869, a courthouse fire in Buckingham County destroyed nearly all records, making Buckingham among the worst of Virginia's "burned record counties." Only one plat book and wills or documents found in the court records of other locales survived. The loss is even more severe since Buckingham County was formed from Albemarle County in 1761, and the Albemarle courthouse was burned by the British in 1781, destroying many early Albemarle records. Very few pre-1861 county records are available. However, researchers have the Buckingham County Virginia personal property tax lists (PPTLs) and land tax lists (LTLs), because the law required that copies of these annual lists be sent to Richmond every year.

With few surviving records to work with, researchers must extract as much as possible from those records that remain, in an attempt to weave them into a plausible, coherent story that fits with the known facts and that can withstand scrutiny.

This paper represents our efforts to answer the two questions posed in the title; here we lay out our case for two related hypotheses:

- that the James Kidd who received a patent for 290 acres of land in 1760 in that part of Albemarle County that became Buckingham County in 1761 was the father of Moses Kidd of Buckingham County and his siblings; and
- that this James Kidd was most likely the James Kidd born on 27 March 1716 in Middlesex County, Virginia to William2 Kidd and his wife Margaret.

Of necessity, our reasoning relies on multiple disparate pieces of evidence, some of which may at first seem unrelated. For this reason, we thought it might be useful to provide readers with a synopsis of the main points we address in this paper, in the order that they appear in this document.

- 1. The 1808 Chancery suit over the estate of Moses Kidd, which survives because it was filed in Superior Court of the District held in Prince Edward County, provides the names of his three brothers (John, William and Benjamin) and six sisters.
- 2. Buckingham County PPTL and LTL entries for Moses' brother William Kidd name the father of William as James Kidd. Therefore, a James Kidd must have been the father of Moses and his other siblings as well.
- 3. Two of Moses' brothers, John and William, were also landowners in Buckingham County, near Moses' land.
- 4. Moses Kidd received his first Buckingham County land from his father (who was not named in the chancery record).
- 5. a James Kidd received a patent for 290 acres on the north side of the Slate River in Albemarle County in 1760. This land was in the part of Albemarle County that formed Buckingham County in 1761.
- 6. Five sons and one daughter of William2 Kidd and his wife Margaret also migrated to Albemarle County in the same time frame as this James Kidd.

7. James 3 Kidd, the son of William 2 (Thomas 1) Kidd and his wife, Margaret is the best (if not the only) fit for the known facts about the James Kidd of early Buckingham County.

See the full exposition below for the evidence we've reviewed and analyzed, to reach the conclusion that James 3 Kidd, son of William 2 Kidd, was the father of Moses Kidd and his siblings.

FACTS RELATED TO OUR HYPOTHESIS

In early July 1798, Moses Kidd of Tillotson Parish, Buckingham County, VA, died at his home near New Canton in northeastern Buckingham County. At his death, he owned 367 acres of land on Phelps Creek (also known as Bear Garden Creek) near the community of New Canton.

The years following his death found Moses' siblings – three brothers and six sisters – in court bringing a chancery suit over the rightful ownership of his land, against his widow Elizabeth Toney Kidd and her Toney relatives. Because the case was heard in the Superior Court of the District, located in Prince Edward County, VA, before being settled in favor of the defendants the Toneys, the papers detailing the suit have survived in the Prince Edward County chancery files. Since Buckingham is a severely burned record county, this is a remarkable piece of fortune for researchers of the Buckingham County Kidds.

At issue in the suit was the will of Moses Kidd, written in 1781 as he was leaving for militia service in the Revolutionary War. This will was presented by his executors (wife Elizabeth, her brother John Toney, and William Wilkinson) on 9 July 1798, the Monday following his death. Moses and Elizabeth were childless, so the inheritance of his large estate, consisting of 367 acres of property and slaves, was clearly a matter of great importance.

The siblings of Moses Kidd, represented initially by his brother John Kidd as the lead plaintiff, contended that the 1781 will was not Moses' rightful will. Without a valid will, the plaintiffs knew that the property of the childless Moses Kidd would revert to his Kidd relatives, with only a dower portion for his widow Elizabeth.

To further complicate matters, some of the numerous witnesses testified in the suit that Moses had written a second will leaving his estate to Sarah (Sally) Falwell, a woman of color with whom he reputedly had at least eight children (named in testimony as Elisha, Mary, Elizabeth, Dinah, Judith, Sarah, Nancy, and John). Although the attorney for Sally Falwell presented the will in her possession immediately following Moses' death, it was quickly tossed out by the court (this was, perhaps, inevitable, given that Sally, though likely free, was a woman of color with little legal standing in 18th century Virginia).

This constellation of events led the siblings of Moses Kidd to sue his widow over his estate in 1803 in the Superior Court of Richmond District, Prince Edward District Court. Thanks to this suit, we are able to learn the names of all his surviving siblings. With this information, we can theorize about the identity of the father of this large Buckingham County, VA family of Kidds.

Brothers of Moses Kidd (named in the 1803-1808 Chancery suit)

- 1. **John**, listed in early records as of Tillotson Parish¹⁸⁴, and a large landowner of 324 acres of property on the Slate River in Buckingham County, died by 1804. Known sons: James¹⁸⁵, Joseph¹⁸⁶, Sherwood¹⁸⁷, Absalom¹⁸⁸, Archibald/Archer¹⁸⁹, Edmond¹⁹⁰, William¹⁹¹. Another possible son is John (Jr.). Testimony in the suit attested that John and Moses were both prosperous landowners, and that Moses had intended his brother John and family to have his property along with his sister Sarah's family.
- 2. **William**, a smaller landowner of 100 acres in Buckingham County near New Canton on Phelps Creek, died by 1807.¹⁹² Wife Ann(e). Known sons: William, Jr., Shadrack, and Robert. Another possible son is Henry. Testimony in the suit attested that Moses believed that if his brothers William and Benjamin got his land, they would not know "how to possess it." ¹⁹³ This suggests they were not as prosperous as Moses and John. In the years following William's death, at least part of his holdings were subject to a sheriff's sale, which possibly indicated insolvency.¹⁹⁴
- 3. **Benjamin**, named as a party to the suit and as Moses' brother, so presumably alive in 1803. Benjamin appears once, in 1786, on the personal property tax lists for Buckingham County (with one white tithe) and is not found on the land tax lists. ¹⁹⁵
 - We believe this to be the Benjamin Kidd who is found in Pittsylvania County, VA and Surry County, NC¹⁹⁶, and who in his Revolutionary War pension application attested that he was born

We believe that he's the Benjamin Kidd who is found on the 1830 and 1840 federal censuses in Surry County, NC, and who applied for a Revolutionary War pension from there in 1845, in which he states that he was born in Buckingham County, VA in 1752 [though Buckingham not formed until 1761]. This Benjamin was dead by 1852, and probably by 1850, since he's not found on the 1850 Surry County, NC census that year.

in Buckingham County in 1752 [sic, Buckingham County not formed until 1761.] Known sons are Jesse and Allen Kidd.

Sisters of Moses Kidd

- 4. **Sarah**, m James Boatright; their son Benjamin Boatwright was named as the second plaintiff in the suit, which suggests that Sarah, and perhaps James, were both deceased by the time of the suit in 1803.
- 5. **Dicey**, m Richard Falwell
- 6. Susanna, m unknown Quarles, widowed by time of suit in 1803. 197
- 7. **Judith**, m James Quarles¹⁹⁸
- 8. **Patsy (Martha)**, m Reuben Southern. The Southern family intermarried with the Kidds; Margaret Kidd, daughter of William2 and Margaret Kidd, married John Southern and they were part of the Kidd family migration to central Virginia, where they owned land on Bear Garden Creek. Reuben is believed to be the son of John and Margaret Southern. This family moved to Stokes County, NC, where Reuben and Patsy Southern sold land in Stokes County in 1828 to Peter Hairston.¹⁹⁹
- 9. **Nancy**, m unknown Smith, no husband named in suit and not identified as a widow. It is possible that this is the Anna Kidd who married Platt Smith in 1790 in Buckingham County.²⁰⁰

While rich in detail about the life of Moses Kidd, the 1803 suit, *Kidd v Kidd*, names neither father nor mother of Moses and his siblings--but it does provide important clues that help us to determine the possible identity of the father of these Kidds.

Among the testimony of the witnesses was a deposition made on 3 July 1804 by Moses' estate executor William Wilkinson, stating that Moses received 200 acres from his father and later added significantly to his initial land holdings.²⁰¹ See Figure below:

Location and proximity: Kidd lands, Slate River and Bear Garden Creek




FIGURE: 1807 map of Buckingham County, showing its waterways and its borders with neighboring counties.

It is possible to determine through Buckingham County land tax records the approximate location of the lands of Moses Kidd, and the proximity of the land of his known Kidd siblings, as well as the land belonging to James 3 Kidd. The parcels that are of interest here are in the northeastern portion of Buckingham County. See Figure below:



In the land tax list descriptions, Moses' land was consistently noted as lying on Glover Road and on Phelps Creek (also known as Bear Garden Creek), 23 miles east of the Courthouse, near New Canton. John's land was noted as lying on the Slate River. William's land was also on Phelps Creek, and near New Canton. Furthermore, William's widow Ann was noted as living near the land of the deceased Moses Kidd, and later William and Ann's sons Shadrack and Robert had possession of 70 acres of the Moses Kidd estate, which they sold in 1824 to F.B. Dean. 202

William and John are very popular American names, and the Kidd family in 18th and 19th century Buckingham County was no exception. When men of the same name appeared on the tax lists, the tax collector often noted additional family information or geographic location, in order to identify

which man was being taxed. In this case, William of New Canton, a landowner with 100 acres, was noted consistently on the tax lists as "son of James." ²⁰³

We know from this descriptor, then, that James Kidd is the father of William Kidd of Phelps Creek, also known as Bear Garden Creek, near New Canton. Since the *Kidd v Kidd* suit identifies William along with John and Benjamin as brothers of Moses Kidd, it stands to reason that this James Kidd is the patriarch of this Buckingham County, VA family.

Given that Moses and Benjamin both served in the Revolutionary War—and that Benjamin stated in his RW pension application that his date of birth was 1752—a man old enough to be their father would most likely have been born by 1720. The Kidd men found in central Virginia who are old enough to fit this date parameter are all believed to be sons of William2 and Margaret Kidd of Middlesex County, VA, six of whom migrated out of Middlesex in the years following the 1727 deaths of both their parents. One of the six sons who left Middlesex County was James Kidd.

In 1760, James Kidd received a land patent in Albemarle County, for the sum of 30 shillings, for 290 acres on the north side of and joining the Slate River, adjoining the land of Edward Kersie.²⁰⁴ This land was in the part of Albemarle that became Buckingham County soon thereafter, in 1761.

Also acquiring land in Albemarle County were James's brothers, Robert, Aaron and John Kidd. The first Kidd land reference found in Albemarle County was in 1746, when a survey dated 13 Oct 1746 was made for Robert Kidd, for 200 acres on both sides of the Hardware River. However, Robert Kidd likely did not retain possession of this land, since a note on the plat reads "Kidd insolvent." 206

Aaron and John Kidd's tracts were further north on the Rivanna River, at Roundabout Creek. Aaron Kidd patented an 80-acre tract in 1763 on the Roundabout Creek.²⁰⁷ John Kidd was named in several deeds (1752,²⁰⁸ 1756,²⁰⁹ 1760,²¹⁰ and 1761²¹¹) as a landowner or neighboring landowner in Albemarle County.²¹²

Also in this area were John Southern and his wife Margaret Kidd, the daughter of William and Margaret Kidd of Middlesex County. In 1749, John Southern purchased from William Webb a tract of 325 acres, lying on Bear Garden Creek, later known as Phelps Creek.²¹³




FIGURE: Land plat of James Kidd, 1760, Albemarle County, drawn by Craig Kilby, researcher, Lancaster County, VA

The Slate River runs across Buckingham County from southwest to northeast, where it flows into the James River near New Canton.

<u>Moses Kidd's</u> land was on Glovers Road and Phelps Creek (formerly known as Bear Garden Creek), 23 miles east of the Courthouse, according to the annual Land Tax List descriptions. This location is just south of New Canton, on the south side of the James River.

Moses' brother John Kidd died with 324 acres on the Slate River by 1804. His land was listed for nearly a decade under the name of his son Joseph Kidd before dropping from the land tax lists in 1812.²¹⁴

Moses' brother William Kidd: there were several men by this name in Buckingham County records, and three were land owners. One of them, listed in the LTLs and PPTLs as "William, son of James," owned 100 acres in 1782; its location was given as on Phelps Creek, near New Canton & 25 miles east of the courthouse. Starting in 1814, the 100 acres is listed as Estate of William Kidd. The estate continues through 1846, when the last of the acreage has been sold, apparently by Shadrack Kidd (William's son) in 1844. The land is subject to several sheriff's sales, which may indicate insolvency of the estate.

Also supporting this relationship is that in 1834, Shadrack and Robert Kidd sold 70 acres of the Moses Kidd estate to F.B. [Francis] Dean. [footnote LTLs and suit]

The other two William Kidds who were landowners weren't proximate to Moses. One, named in the Buckingham LTLs as "William Sr.," owned 190 acres from 1787-1803, after which he drops from the LTLs in 1804. A second William Kidd, listed as "William, son of John" in the LTLs, is likely the nephew of William Kidd of New Canton and first appears with land (60 acres) in Buckingham County in 1806. His land was described as "on the Slate River, 20 miles NE of the courthouse.

We find no land in Buckingham County in the name of Benjamin Kidd.

CONCLUSION ONE:

We believe that the record makes it highly probable that the father of Moses Kidd and his siblings was the James Kidd who in 1760 patented land on the Slate River, in proximity to these other Kidds.

Identifying James Kidd of early Buckingham County

Having made the case that the James Kidd who patented 290 acres of land on the Slate River is the father of Moses Kidd and his siblings, we turn to the next question: what is the identity of this James Kidd?

We believe that this James Kidd is likely James Kidd, son of William2 and Margaret Kidd of Middlesex County, VA.

Supporting evidence for this theory:

- A man old enough to be the father of children born in the early 1750s would likely have been born by 1720 in this era.
 James Kidd, son of William and Margaret, was baptized 28 Apr 1716 in Christ Church Parish in Middlesex County, VA.
- 2. Six of William2 and Margaret Kidd's sons—Robert, John, James, Aaron, Duel, and Moses—and one daughter Margaret Kidd Southern, wife of John Southern, have been identified in central Virginia records, confirming their migration from Middlesex County to central Virginia by the mid-1700s.
- 3. There is a connection between the Parish family of Goochland County and James Kidd and John Kidd. By 1755, according to the records kept by Rev. William Douglas, this James Kidd had married Morning Parish, daughter of Henry Parish.²¹⁵ At least six years earlier, James' brother John Kidd had married Ruth Parish, daughter of Henry Parish and sister to Morning.

The Parish connection is a useful clue to identifying this James Kidd and tying him to John Kidd, son of William2 Kidd of Middlesex County.

4. Three of the daughters of James Kidd and Morning Parish are listed in Rev. William Douglas's register of marriages and births. Dicea Kidd, daughter of James Kidd [published as Kill] and Morning Parish, was born 6 Aug 1756 and baptized 5 Sept 1756.²¹⁶ Mary Kidd, daughter of James Kidd [published as Caid] and Morning Parish, was born 11 Jan 1759 and baptized 18 Feb 1759.²¹⁷ Sally Kidd, daughter of James Kidd and Morning Parish, was born 3 Feb 1761 and was baptized 29 Mar 1761.²¹⁸

The names of two of these daughters – Dicea/Dicey and Sarah/Sally – reasonably match the names of two siblings of Moses Kidd given in the suit *Kidd v Kidd* in Buckingham County, VA (1803). Dicey Kidd was listed as the wife of Richard Falwell, and Sarah as the wife of James Boatwright.

5. The absence of any other known James Kidd in central Virginia records during the mid-1700s. Our reasonably exhaustive search has not found evidence of any other James Kidd, born by 1716, *anywhere* in Virginia. There is no other James Kidd to consider as an alternative suspect.

All records found to date indicate that all the Kidds in eastern or central Virginia prior to 1760 are by definition the descendants of Thomas1 Kidd of Middlesex County. No records have been found to indicate the presence of another unrelated branch of Kidds.

Thomas1 Kidd had two sons, Thomas2 and William2 Kidd.

Thomas2 had five known sons, and none of them were named James Kidd.

Thomas2's first son, Thomas3, had two known sons. Neither was named James, and both were born after 1716.

Thomas2's second son, John3, did have a son named James, born in 1738. This James Kidd could not have been the father of Moses, who was likely born by 1743. He lived out his life in Middlesex County where he was a tavern owner in the town of Urbanna and left numerous records in Middlesex County.

Thomas2 Kidd's third son Daniel3 was born abt 1696 and had no known son James; the Essex County men suspected to be his sons were named Henry, Isaac, and William. Thomas2 Kidd's fourth son Henry, born in 1707, was not named in his father's 1727 will and likely died before 1727.

Thomas2 Kidd's fifth son, William was born in 1716, and could not have had a son born before 1730.

William2 Kidd did have a son named James, born in 1716 in Middlesex County. This James is our top candidate for the father of Moses and his siblings.

What about the other sons of William2 Kidd? Might any of them have a son named James, born by 1720 or so, who was enough to have fathered Moses and his siblings? This seems improbable, to say the least.

William3, the eldest son of William2, was born circa 1707; his two known sons (William4 and John4) were born in 1729 and 1733 respectively in Middlesex County.

Robert3, William2's second son, was born circa 1703, and would be very unlikely to have fathered a son by 1720. He had no known descendants and disappears from the central Virginia records by 1746.

All eight of William2's other sons were born after 1706, too late to have fathered a son by 1720. Of these sons, only Duel had a known son named James, who was born in 1737 in Middlesex County and so was too young to be the father of Moses Kidd.

CONCLUSION TWO

By process of elimination, James 3 Kidd, son of William 2 Kidd, is by far the most likely to be the James Kidd of Slate River in Albemarle/Buckingham County in 1760.

Based upon the above analysis, the James Kidd who patented 290 acres on the north side of the Slate River in 1760, was James 3 Kidd, the son of William 2 Kidd and his wife Margaret, born in 1716 in Middlesex County.

Evidence against this theory is that James Kidd, if he were the father of Moses Kidd, was likely married at least a decade before 1755. In 1764, Moses Kidd appears on an early Buckingham County, VA tax list fragment that was found in the records of Prince Edward County. In order for Moses to be old enough in 1764 to be on a tax list, he would have been born by 1743. Did James have a first wife (which seems likely); or was this marriage date an estimated "no later than" marriage date, as were many others in the published version of Rev. William Douglas's register?

Other unreconciled evidence is that the Douglas Register includes the 1759 birth/baptism of a Mary as a child of James Kidd and Mourning Parish. There is no Mary or Polly among the siblings of Moses Kidd. It is possible, however, that Mary had died or moved away prior to the *Kidd v Kidd* suit.

Research into the Boatwright, Quarles, and Falwell families – and additional research into the landowners and neighbors of the Kidds who lived near New Canton in Buckingham County – may help to confirm or refute this theory.
